The Mayor's Corner: Back To Summer

On June 16th, the City held a virtual meeting to provide an update on Clean Water Lakewood, our City's plan to improve and update our 100-year old sewer system. The discussion also included how we plan to use American Rescue Plan Act funding to reduce rate increases and implementation of the new Impervious Surface Fee to help fund a modern sewer system that better protects our waterways from pollution. I look forward to presenting this to City Council later this month.

As of late May, Lakewood has officially entered into our energy supply contract with NOPEC, which will provide the city's public facilities with 100 percent renewable energy. Lakewood is one of the first communities in Ohio to commit to a completely renew-

able energy contract. I believe that sustainability and clean energy are foundational values of Lakewood and its residents, and I hope to continue to expand on these renewable energy efforts for years to come.

The City of Lakewood has teamed up with Lakewood Vineyard Church and Friends of Madison Park to create a new community event series entitled "Third Thursdays in Madison Park." Four free events will take place during the third Thursday this summer and will feature family-friendly activities and local restaurants at Madison Park. Events will be held on June 17th, July 15th, August 19th, and September 16th. More information can be found at LakewoodOH. gov, www. FriendsofMadisonPark.org, and LakewoodVineyard.com.

In addition to the Third Thursdays in Madison Park series, Lakewood will be hosting many of its regular yearly festivals and events this 2021 season. Friday Night Flicks, Fireworks, Lakewood Arts Festival, and many other customary events are back and currently scheduled to take place this summer with health and safety precautions. FAQs About Surface Fees

What is an impervious surface?

Impervious surfaces are the hard surfaces on a property like pavements and roofs. These surfaces cause rainwater and snowmelt to run off the property into the City's storm drains. During large storms,

this water can overwhelm the City's combined stormwater and sewer system that makes up our wet weather infrastructure and cause pollution to run into Lake Erie.

What is an Impervious Surface Fee?

The City needs to invest about \$274 million into upgrading and modernizing our 100-year-old sewer system to meet the regulatory requirements of both the Ohio Environmental Protection Agency (EPA) and United States EPA and prevent pollution from reaching the Rocky River and Lake Erie. Currently we are funding these infrastructure projects from the water and sewer rates we charge customers on their water bills, which is based entirely on the volume of drinking water a customer uses. However, water use is not connected to the demand a property puts on the City's wet weather infrastructure.

"Waist management" helps avoid complications of diabetes.

Healthy eating and exercising should be a habit, not just a quick fix. It's important for your health, too – especially for people with diabetes.

"Being overweight increases your chance for developing type 2 diabetes. Those

with diabetes have blood sugar levels that are harder to manage which can lead to complications," explains Carolyn Garvey, RDN, LD, CDCES, a certified diabetes care and education specialist at Cleveland Clinic.

Diabetes care and education specialists at Cleveland Clinic include registered dietitians (RD), registered nurses (RN) and pharmacists. In the weight management program, they teach meal planning, lifestyle changes, healthy coping, medication management, and ways to boost activity.

"There is no one meal plan to manage diabetes. I take an individual approach with my patients when it comes to losing weight," says Carolyn. "A diabetes specialist like myself can help create a plan specific to each patient's needs and lifestyle."



The City is considering implementing an Impervious Surface Fee to help us recover the costs of these wet weather infrastructure improvements in a way that is more directly tied to the demand customers place on this infrastructure. The Impervious Surface Fee would be a small set amount for single family residential and small multifamily properties, since these properties have very similar amounts of impervious surfaces across the entire city. For large multifamily, commercial, industrial, and institutional properties, which have more variable amounts of impervious surfaces, the fee would be based on the amount of paved and hard surfaces each property has. The Impervious Surface Fee would be placed on your water bill as a separate line item.

What is driving the need for an Impervious Surface Fee?

Part of our City's charm is that we are a pre-

World War II community on the shore of Lake Erie, but beneath our streets is 100-year-old sewer infrastructure that is causing pollution to flow into the lake during major storms. To comply with the


US EPA regulations, we must invest in infrastructure at a fast pace, and this means that a dedicated funding source is needed. The City is considering an Impervious Surface Fee to equitably allocate the costs of improving our wet weather infrastructure and more closely reflect each property's demand on the wet weather infrastructure itself.

How will the City use the money collected from an Impervious Surface Fee?

An Impervious Surface Fee would help transition the City toward a sufficient and stable revenue source to effectively implement its Clean Water Lakewood Integrated Wet Weather Improvement Plan (IWWIP) that has been submitted to Ohio EPA. This will allow us to meet the requirements of the City's NPDES MS4 Permit.

I've never heard of an Impervious Surface Fee, do other cities have this?

Charging for wet weather infrastructure in this way is something cities continued on page 9




At this point in writing, I realized something: the thread doesn't exist.

June 1965, The Rolling Stones released "I Can't Get No"... Satisfaction. Nearly sixty years later, satisfaction eludes many.

What is satisfaction anyway? Satisfaction is the fulfillment of a need or a desire. Satisfaction is also strongly linked to happiness, which greatly affects general well-being. If you have your needs met, the first tier of human fundamentals is covered. If your desires are fulfilled, generally you have a more exciting life. Raising your joy factor promotes good health. Happy people tend to sleep better, eat healthier, move more, communicate with kindness, and have meaningful relationships. All of which lead to greater well-being and longevity.

What keeps us from being truly satisfied? For one, most people believe that true happiness, or satisfaction comes from a particular occurrence, versus being in a state of satisfaction or generally happy as a common practice and state of mind. Becoming good at anything, including being satisfied, requires patience, practice, and consistency.

How to cultivate greater life satisfaction:

Change Your Words: Changing your vocabulary by adapting statements that use the word satisfaction regularly sets a tone of being happy and content. For example, "I am deeply satisfied with my home, it is very comfortable and cozy." "The weather satisfies me, especially when a cool breeze comes over the lake." "This meal is very satisfying, so delicious and filling."


Trigger Satisfaction: The more you view new words, the greater the likelihood of using them. Postit notes, or 3X5 help jump start your satisfaction statements. "I am living a deeply satisfying life," "Happiness is in me and around me," "What makes me truly satisfied today?" Use happiness and satisfaction prompts liberally in

your home, car, or office space and watch your mindset shift to happiness

Play With It: Anytime we make something that is good for us a game, we commit deeper, because for the most part, most of us want to have more fun. Consider posting a satisfaction chart, with a color slide for each satisfaction caught. Once you reach your goal, take the family out on an adventure in nature, play putt putt, watch a sunset, or take turns choosing the reward to add fun, excitement, and memories to your self-improvement game.

When you commit to living deeply satisfied, you create new pathways in your brain that practiced continually expand your feel-good receptors and create Neuroplasticity, new pathways in the brain that help you stay sharp. The benefits of living in satisfaction extend beyond ourselves, and create a ripple effect of joyfulness in our community and world.

throughout Ohio and across the country do because it is the most fair and equitable method of charging for this service.

What impact will an Impervious Surface

Fee have on my monthly bill?

For residential customers, the Impervious Surface Fee would be a fixed \$2 fee on monthly water bills. Some multifamily, commercial, industrial, and institutional customers with lots of impervious (hard or paved) surfaces would pay a fee based on the amount of paved and hard surfaces on their property those that have large parking areas or rooftops, because these surfaces place a greater demand on the City's wet weather infrastructure.

If approved, when would I see the Impervious Surface Fee on my water bill?

The Impervious Surface Fee requires approval by City Council. If approved, it would be implemented January 1, 2022.

I rent my home and pay a water bill; will I pay this fee or does the property owner pay it?

The Impervious Surface Fee will be assessed on

your water bill, regardless of whether you are the property owner. We are aware that some properties in Lakewood have more than one household living there. In this case you would be billed for only your portion of the property's total Impervious Surface Fee.


If I reduce the amount of impervious surface on my property, can I get a reduction in the fee?

Currently, the City is not providing a way for property owners to receive a reduction in the Impervious Surface Fee for reducing the amount of impervious surfaces, although we are considering this for the future.

What is the City of Lakewood doing to keep my water bill affordable?

The pandemic has created many challenges for residents and businesses and the City is seeking to balance the regulatory requirements coming from Ohio EPA with charging fairly and affordably for improving our wet weather infrastructure. We are very hopeful that some of the funding that we will receive from the American Rescue Plan Act (ARPA) can be used to help reduce the impact of recent water and sewer rate increases on our customers. Lakewood Native And Creative, Cassie Bishop Is Hemorrhaging Music This Year

Lakewood native and creative, Cassie Bishop has music and art in her veins. Musically, she describes her original songs and sound as a dark ambient folk. You can decide when you hear her music while you read this article. She has released her most recent recordings under the name "Origami Moon" found on Bandcamp or Spotify.

Bishop's creative ways have translated into her current full-time gig as a personal designer with Stitch Fix, where she helps create custom wardrobe options for individuals that she has never met. This career path took a front row seat at the start of the pandemic. She had prior been managing an art studio, which required an inperson component.

It was during the pandemic that she started working solely from home. This gave her the time and space to conceive and gestate her latest solo EP release, "My Raw Heart" out on July 2. "Writing songs is part of me," says Bishop, "...even if no one ever listened, it is a way to release emotions and to express my truth in a tangible way."

Cassie started writing songs and playing in bands during her time in high school at age 17, but she confesses to having taken an occasional hiatus. "I would join bands and then stop playing for periods of time," says Bishop. During those times however, she accomplished quite a bit. She did some travelling before coming back home to earn her bachelor's in psychology and a master's in education from Cleveland State University. Not to mention, she also wrote and published a children's book.

Still, with music pulling her motivation she continued coming back to writing songs and collaborating with area musicians, moonlighting in multi-

ple bands, including a local band called "How to Breathe Under Water" where she met musician/bandmate, Genevive Jencson. After touring the Cleveland club scene for nearly 3 years, the two separated from the band forming a duo together under the name, "Shy Moon." Cassie had already honed skills recording in some of the earlier bands she had been involved with, and under the name "Shy Moon" had released a 2018 album called "The Year I Played Dead." The "Shy Moon" duo had been working on a follow-up to 'Played Dead' with an album called, "Glow in the Dark," when Covid 19 brought that effort to a pause.

It was during the months of the pandemic that Cassie continued writing and recording on her own. "I recorded songs in my living room before sending them off to be mixed," explains Bishop. This effort resulted in her July 2nd release of the EP, "My Raw Heart" for her solo project, "Origami Moon." Bishop performed and recorded all the instruments and whimsical vocals herself with added bongos from her partner Steve Sladic. The final mixes also included embellishments from mixing engineers Rick Spitalsky and Dylan Glover who each took on a few songs for the project. Cassie felt confident that the two would translate her recordings into the sound she was going for. She explains: "It is so hard to describe what my music sounds like... ambient, indie."

"Origami Moon" and Cassie's Duo "Shy Moon" have no upcoming performances to speak of yet. However, they plan to get out there sooner rather than later, as musicians continue to assess their comfort in venturing back out to perform after the pandemic. The "Shy Moon" duo, however, will still

be planning on firing up the laptop this summer to finish up their album, "Glow in the Dark." And Cassie also has big plans for recording into the fall, releasing more of her darker music around Halloween.

When asked what her best-case success story could be for her music, Cassie says: "I would love to get some of my music placed into television and movies." And the music most certainly fits the bill.
